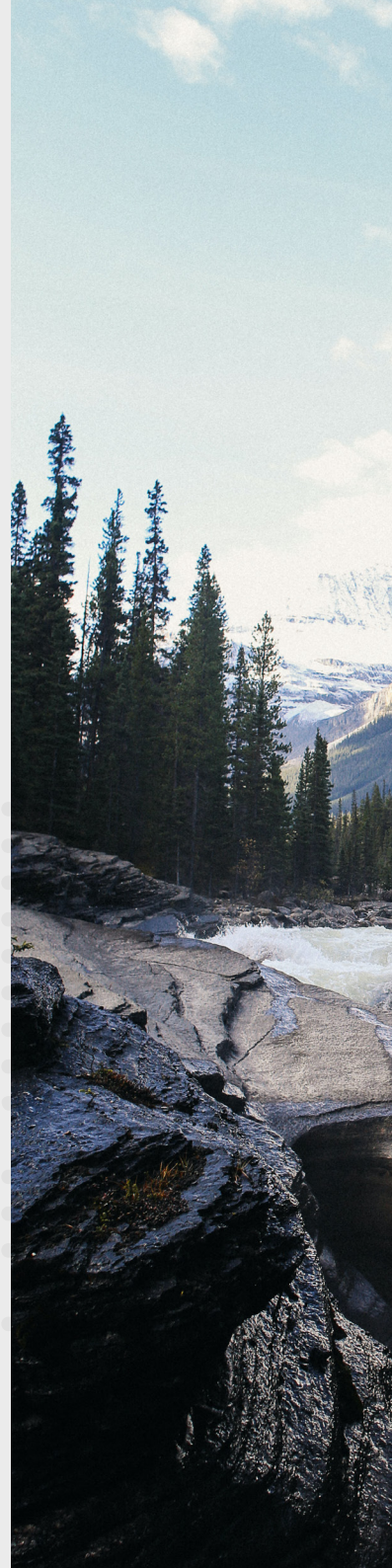

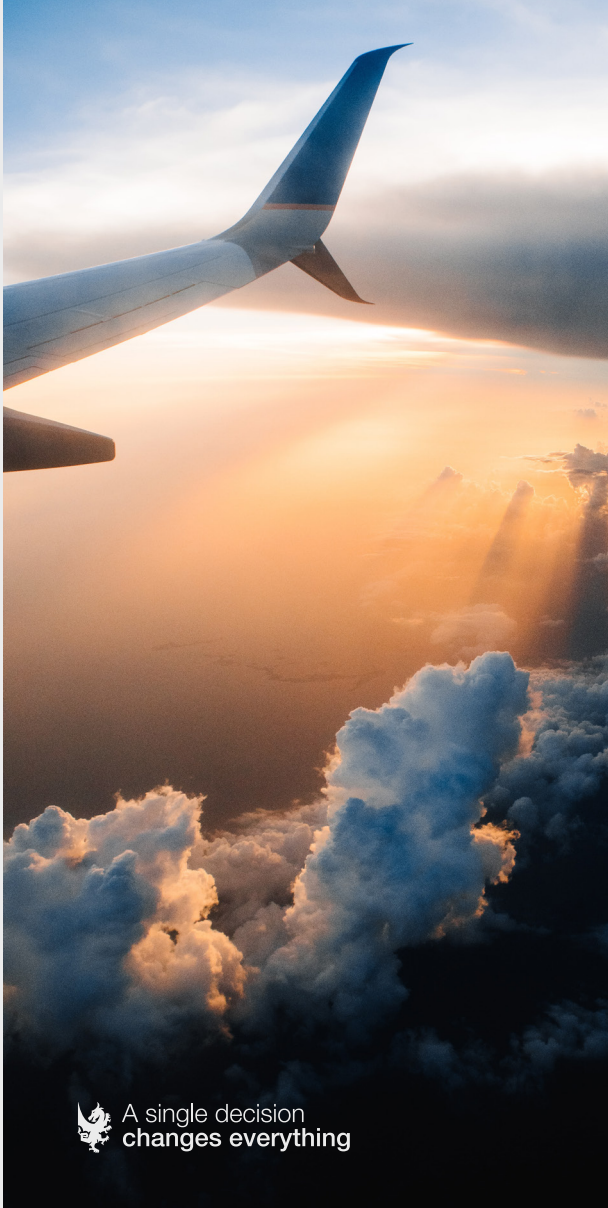

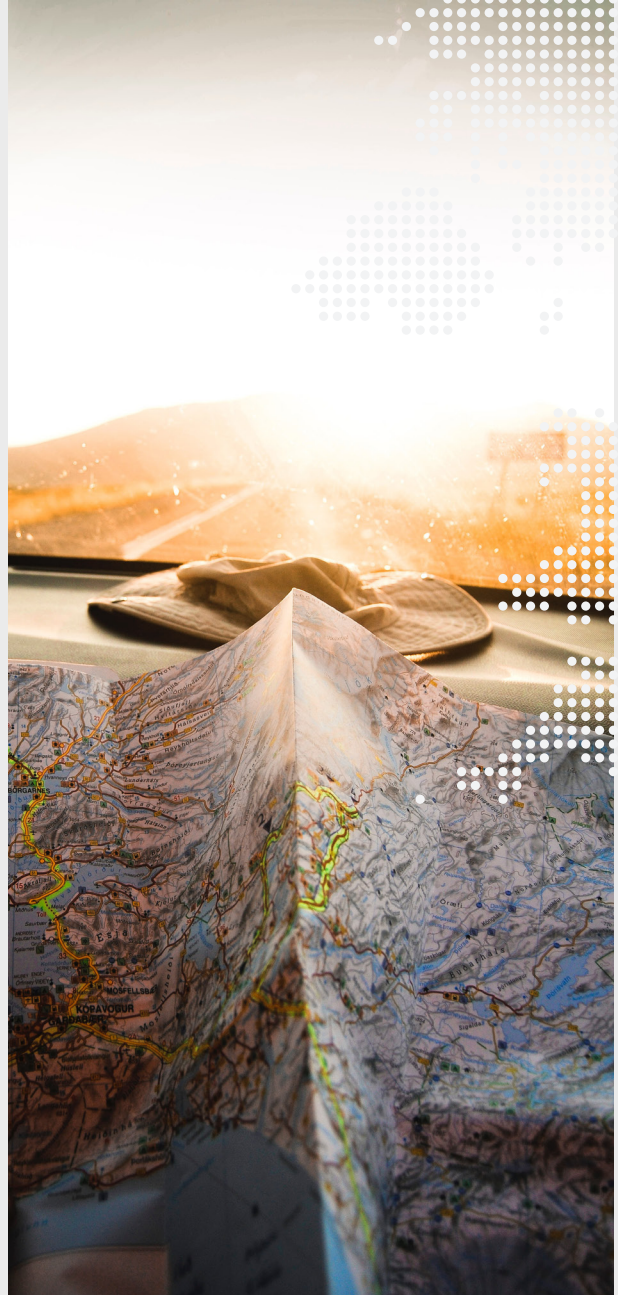

My vision for Draxon has always been to help individuals and their families in similar circumstances to truly enrich their lives.

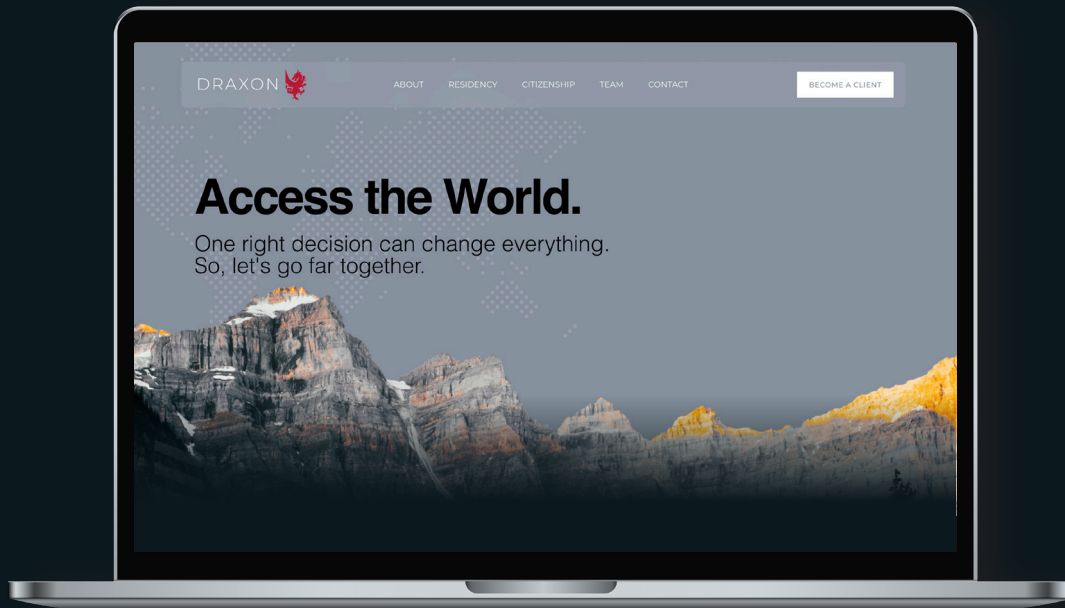
